



MEMBER CODE OF CONDUCT

The NIPF Member Code of Conduct outlines the expected behaviour and ethical standards for all members within the Northern Ireland Powerlifting Federation.

This code helps ensure a positive and respectful environment for everyone involved in the sport.

The following pages list the key points of the NIPF Member Code of Conduct:

RESPECT FOR OTHERS

Treat all individuals with respect, regardless of their role or position within the organisation.

SPORTSMANSHIP

Display good sportsmanship at all times, both on and off the platform, and encourage others to do the same.

FAIR PLAY

Compete fairly, following all rules and regulations, and avoid any form of cheating or unsportsmanlike behaviour.

POSITIVE ATTITUDE

Maintain a positive attitude, promote a positive atmosphere, and support fellow lifters in their endeavours.

ETHICAL CONDUCT

Adhere to ethical conduct standards both within and outside of competitions, upholding the integrity of the sport.

ANTI-DOPING COMPLIANCE

Comply with all anti-doping regulations and refrain from using prohibited substances or methods.

SAFETY

Prioritise safety during training and competitions, ensuring the well-being of oneself and others.

COOPERATION

Collaborate and cooperate with NIPF officials, coaches, and fellow members to foster a sense of unity and community.

CONFLICT RESOLUTION

Handle conflicts and disagreements in a respectful and constructive manner, seeking resolution through appropriate channels.

PRIVACY AND CONSENT

Respect the privacy and consent of others, obtaining necessary permissions before sharing any personal information or media.

REPRESENTATION

When representing the NIPF, uphold the organisation's reputation and values through positive behaviour and conduct.

VOLUNTEERISM

Contribute to the growth of powerlifting by volunteering time, skills, or resources to support NIPF activities and events.

PROFESSIONALISM

Maintain professionalism in interactions with others, regardless of the context or situation.

INCLUSIVITY

Embrace diversity and inclusivity, treating all individuals equally and creating an environment free from discrimination.

COMPLIANCE

Abide by all NIPF policies, rules, and regulations, and follow instructions from authorised personnel.

SOCIAL MEDIA USE


Exercise responsible and respectful behaviour on social media platforms when discussing or representing the NIPF.

REPORTING VIOLATIONS

Report any violations of this code of conduct to appropriate NIPF authorities.

Understand that failure to adhere to this code of conduct may result in disciplinary actions as outlined in NIPF policies.
